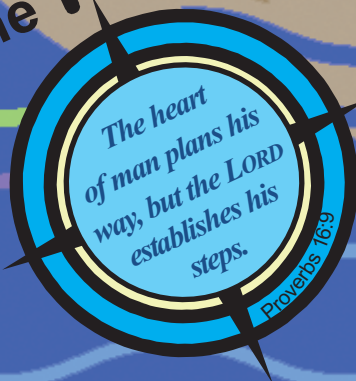

CODE OF BEHAVIOR

1. I will respect the property of others and all program facilities and property.

6. I will follow the schedule and all appropriate instructions of all personnel aiding this event including but not limited to chaperones, support staff, transportation personnel, and administration.
7. If I damage camp property, I (or my parents/guardian) am responsible and must make restitution.
8. Littering is prohibited throughout the camp; as is any carving, damage to wildlife, damage to plants, etc.
9. I agree to full participation in the program.
10. I agree to respect my peers by listening to others and allowing their opinions and points of view to be shared.
11. I will treat all other people with respect, not cause any intentional harm (physically, emotionally, mentally, or spiritually) to any other person in any way.
12. I understand that "lights out" will be strictly enforced at the time indicated in the schedule.
